IHSAA STATE GIRLS SWIM QUALIFIER AND PARTICIPANT

Mrs. Ashley Schutte, Madison Consolidated High School Swim Coach addressed the Board: "Thank you for the opportunity to recognize members of our State-Qualifying swim team members this evening.

This season was an incredible success building upon a foundation established by these and other young athletes going back more than 10-12 years...when many of them were just learning to swim. We were very anxiously looking forward to this season, in particular, knowing that we had the opportunity to help them do something very special.

It wasn't easy. There were injuries, rigorous demands of busy schedules, and outside distractions but each of them made swimming and their teammates a priority. They set exemplary examples of what hard work and dedication can do to drive success, they pushed one another to be better and faster each day, and they have created a culture and an environment for our younger athletes to aspire to be a part of.

Before we dig in...I wanted to share a bit about our state tournament as compared to other sports. Swimming is an open-class sport - meaning that each athlete is competing for a spot in a very narrow field full of talent. There are two ways to advance to the State level, 1) you win your sectional event OR 2) qualify on time and hope there is a spot available once all of the results are in. We did it both ways this year!

We tell the kids that Thursday prelims are the 'sectional' - you have to get through to have a lane. Saturday finals are the 'regional' - if you want to go to the show - you have to earn it. If you are lucky enough to advance one way or the other...Friday prelims are the 'semi-state' and Saturday is the Final.

There are 20 Sectionals throughout the state. Each event winner advances automatically. There are 32 spots available in each event, so the IHSAA fills those remaining spots with the next fastest 12 swimmers/teams in each event to fill the field. To reach the State level in swimming, particularly in Indiana, is something to be very, very proud of.

For the first time in program history, we participated in both the Girls' and Boys' State Swim Meets in the same season."

As a freshman, Lilly is your 100 Free Sectional Champion with a time of 54.00. Her sectional swim earned her an automatic berth to the State Finals where she was seeded 28th in the state. Her prelim swim was 54.64 placing her 28th overall in the state. It was a ridiculously fast meet with 5-6 meet and national records being set in as many events that Friday night.

As we were sitting there waiting, Lilly shared with John and me, "this would be a lot more fun with more of us here!" We agree and that is the goal!

Also, while at the Sectional meet, Lilly placed 3rd overall in the 50 Free and helped set new benchmarks as a member of the record-breaking 200 IM and 200 Free Relay teams. (The former 200 Free Relay time was a record from 2010)

Our ladies combined to score 215 points to finish 4th overall behind Floyd, Jeff, and Seymour.

In addition to her high school swim success, Lilly competed last weekend at the USA Swimming Southeast Divisional Championship Meet at Center Grove where she won the 14U 50 Free. She will head back to the Natatorium to compete next at the Age Group State Event on March 17-19, 2023. She will compete in 6 events."

"This group took option #2 to get to the State meet. Having had Floyd Central in their sights all season and creating exciting swims all day - they knew they had a shot in both the medley and free relays. They put together a recordbreaking effort at 1:28.95 but fell short of a sectional win and finished 2nd in the event by just 6/10 of a second. Bittersweet defined the moment.

It wasn't until Sunday morning that we learned they had made it through on a qualifying time. The psych sheet had them seeded at 27/32 (meaning they had 5 slower times behind them) and to put into perspective the competitive nature of the field, teams seeded 20 - 27 started at 1:28.10 and ranged to our 1:28.95 - we knew they had a shot at some magic!

This group, along with Max Thompson, our alternate, competed and swam a 1:29.00 to move up and finish 22nd in the state overall. They tied with Franklin and finally outswam our sectional foes Floyd Central.

Our gentlemen, with 8 scoring participants, scored 280 points and finished 3rd overall at the Sectional meet behind Floyd and Seymour. Individually,

Gavin is also a member of the record-breaking 200 Medley Relay team, placed 4th overall in the 50 Free and 7th in the 100 Free, is a four-year letterman, and has earned Academic All-State recognition from the Indiana High School Swim Coaches Association (IHSSCA).

Peyton is also a member of the record-breaking 200 Medley Relay team, placed 3rd overall in the 50 Free, and 2nd in the 100 Back.

Kyle placed 5th in the 100 and 200 Free and was a member of the 3rd place 400 Free Relay team.

Cam is also a member of the record-breaking 200 Medley Relay team, placed 2nd in the 50 Free, and now holds the 50 Free school record at 21.99, and placed 2nd in the 100 Breast.

I believe this season we learned that schools of any size, regardless of conference/no conference, and team size can compete with anyone when a program is built on a solid foundation, the kids work hard, and athletes believe they can win.
