Resolution for Declaration of Official Intent to Reimburse Expenditures

WHEREAS, Madison Consolidated Schools (the "School Corporation") intends to renovate and improve Madison Consolidated High School Security and Building Upgrades and make Security and Building Improvements to all other school facilities throughout the district (the "Projects"); and

WHEREAS, the School Corporation reasonably expects to reimburse certain costs of the Projects with proceeds of debt to be incurred by or on behalf of the School Corporation in an amount not to exceed \$2,000,000 per Project; and

WHEREAS, the School Corporation, expects to issue debt for the Projects and to use the proceeds to reimburse or pay costs of the Projects; and

NOW, THEREFORE, BE IT RESOLVED that the School declares its official intent to acquire, construct or rehabilitate the Projects with proceeds of debt incurred by the School Corporation in an amount not to exceed \$2,000,000 per Project for the purpose of paying or reimbursing costs of the Project.

BE IT FURTHER RESOLVED, that the School Corporation reasonably expects to reimburse itself from proceeds of obligation issued by the School Corporation for costs of the Projects paid prior to the issuance of the obligations.

APPROVAL OF ICE MILLER FOR LEGAL COUNSEL FOR BOND ISSUE

Upon the recommendation of Dr. Studebaker-Bolinger and a motion by Mr. Kring, seconded by Mrs. laCour, the Board voted, 5-0, and the motion carried to approve Ice Miller for legal counsel for bond issue.

APPROVAL OF H.J. UMBAUGH AND ASSOCIATES FOR FINANCIAL CONSULTANT FOR BOND ISSUE

Upon the recommendation of Dr. Studebaker-Bolinger and a motion by Mr. Glesing, seconded by Mrs. L. Imel, the Board voted, 5-0, and the motion carried to approve H.J. Umbaugh and Associates for financial consultant for bond issue.

APPROVAL OF PARTNERSHIP WITH THE INDIANA DEPARTMENT OF WORKFORCE DEVELOPMENT (JAG) AND MADISON CONSOLIDATED SCHOOLS

Upon the recommendation of Dr. Studebaker-Bolinger and a motion by Mr. Kring, seconded by Mr. Glesing, the Board voted, 5-0, and the motion carried to approve the partnership with the Indiana Department of Workforce development (JAG) and Madison Consolidated Schools.

Mr. Kring said he knows firsthand how JAG impacts students. He said JAG is a phenomenal program.

<u>APPROVAL TO ENTER INTO ECO15 GRANT FUNDING AGREEMENT WITH JEFFERSON COUNTY</u> INDUSTRIAL DEVELOPMENT CORPORATION

Upon the recommendation of Dr. Studebaker-Bolinger and a motion by Mr. Kring, seconded by Mr. Glesing, the Board voted, 5-0, and the motion carried to approve to enter into EcO15 grant funding agreement with Jefferson County Industrial Development Corporation in the amount of \$20,000.00.

APPROVAL OF MEMO OF UNDERSTANDING BETWEEN MCS AND PATHWAYS

Upon the recommendation of Dr. Studebaker-Bolinger and a motion by Mrs. laCour, seconded by Mrs. L. Imel, the Board voted, 5-0, and the motion carried to approve the memo of understanding between MCS and Pathways.

APPROVAL OF PART B, 611 AND 619 SPECIAL EDUCATION GRANTS

Upon the recommendation of Dr. Studebaker-Bolinger and a motion by Mr. Kring, seconded by Mr. Glesing, the Board voted, 5-0, and the motion carried to approve the Part B, 611 and 619 Special Education Grants. The 611 allocation is \$905,503.00 and the 619 allocation is \$33,382.00.

APPROVAL OF AGREEMENT TO PROVIDE PHYSICAL THERAPY

Upon the recommendation of Dr. Studebaker-Bolinger and a motion by Mr. Glesing, seconded by Mrs. laCour, the Board voted, 4-0-1, with Mrs. J. Imel abstaining, and the motion carried to approve the agreement to provide physical therapy with Lindsay Black in the amount of \$50.00 per hour.

APPROVAL OF AGREEMENT TO PROVIDE OCCUPATIONAL THERAPY

Upon the recommendation of Dr. Studebaker-Bolinger and a motion by Mr. Glesing, seconded by Mrs. laCour, the Board voted, 5-0, and the motion carried to approve the agreement to provide Occupational Therapy with Becky Smitha in the amount of \$55.00 per hour.

APPROVAL OF NAMING MCHS TRACK IN HONOR OF MARY LOUISE EISENHARDT

Mrs. J. Imel introduced Mrs. Diana Wehner, Ms. Edna Curl and Ms. Michele Ward, who presented the proposal to the Board. Ms. Curl gave the following statement: "There are currently 10 girls' sports that are sanctioned by the Indiana High School Athletic Association. This has not always been the case. These 10 sanctioned girls' sports were made possible, due in part, to the pioneering efforts to promote girls athletics by Miss Mary Louise Eisenhardt.

After 6 years of teaching, Miss Eisenhardt came to Madison in 1953 to teach P.E. and Health. At that time, throughout the state of Indiana, she became a driving force behind the effort to introduce sports competition to females and to ultimately see girls' athletics officially recognized by the governing body of the IHSAA. This was not an easy cause to take on and was met with much negativity and many nay-sayers. If you get an opportunity to speak with Miss E, ask her about some of the letters she received during this time of change. You would be surprised by some of the so-called reasons people gave against allowing females to participate in sports.

She did not let these obstacles deter her from her goal. As part of her vision, she introduced the Girls Athletic Association to Madison High School and she made it one of the more active programs in the state of Indiana. She stressed the importance of sportsmanship and citizenship to her team members to the same degree as skill development. Due to her tireless dedication to girls' athletics, when the IHSAA finally sanctioned girls' sports, Madison's female athletes were instantly successful because of the Girls Athletic Association that Miss Eisenhardt started.

Michele, Diana, and I all played sports in high school here at Madison. We have often discussed the many life lessons that we learned through our participation in girls' athletics. Because of Miss E's efforts, we were given opportunities that girls before us did not get. Current female athletes across the state of Indiana may not know who Miss Eisenhardt is, but she IS a main building block in the foundation of girls' athletics in this state. The three of us believe that her dedication to girls' athletics should be honored and since she gave so many years to Madison Schools, we believe that honor should happen here. We believe the track at the high school should be named after Miss Eisenhardt so that everyone who enters that venue will know her name. She was the first coach for many girls' sports at Madison, including track, and this was the last sport from which she retired. We respectfully request that you bestow this honor on Miss Mary Louise Eisenhardt."

Mrs. Wehner said the sign unveiling and reception in Miss Eisenhardt's honor would be Friday, September 4th at 5:30 p.m. at the football field.

Upon the recommendation of Dr. Studebaker-Bolinger and a motion by Mr. Glesing, seconded by Mrs. laCour, the Board voted, 5-0, and the motion carried to approve the naming of MCHS track in honor of Mary Louise Eisenhardt.

Mr. Kring said he was completely honored to be part of the Board that is recognizing Miss Eisenhardt. He said how fitting was it to recognize a State track runner-up at the board meeting as well.

Mrs. J. Imel said Miss Eisenhardt also taught everyone how to swim and she is a great lady.

Miss Eisenhardt said she thoroughly enjoyed working and teaching.

Students in grades K-12 will be participating in 6 scheduled eLearning Days during the 2015-16 school year. On these dates students who have Internet access will have the opportunity to work at home on lessons published online by their teachers. For those without Internet access or those preferring to work at school, transportation will be provided as normal, our schools will be open, and lunch will be served. The scheduled dates for our eLearning Days this year are:

September 30, 2015 October 30, 2015 November 3, 2015 (Election Day) January 20, 2016 February 10, 2016 April 6, 2016

Permission forms will sent home with students so that parents can indicate whether their student will be working from an off-campus location during our eLearning Days. Permission forms are due back by September 11. Any student without a signed permission form indicating they will be working off-campus will be expected to show up at school on our eLearning Days.

Dr. Studebaker-Bolinger said the eLearning dates would be sent to parents via social medias and newsletters.

Mrs. laCour asked when we would find out about the use of eLearning days for snow? Dr. Studebaker-Bolinger said we should hear closer to snow season.

APPROVAL OF COLLECTIVE BARGAINING AGREEMENT FOR 2015-2016 BETWEEN THE BOARD OF SCHOOL TRUSTEES AND THE MADISON TEACHERS ASSOCIATION

Upon the recommendation of Dr. Studebaker-Bolinger and a motion by Mrs. L. Imel, seconded by Mrs. laCour, the Board voted, 5-0, and the motion carried to approve the Collection Bargaining Agreement for 201-2016 Between the Board of School Trustees and the Madison Teachers Association.

Dr. Studebaker-Bolinger said she was thankful for the cooperation during negotiations. She said informal negotiations began earlier in the summer which lead to a quick settlement for our team. Dr. Studebaker-Bolinger said some difficult decisions have been made in the past and expects our general fund revenue to decline by approximately 2.6% during the 2015 school year however we were able to provide a 3% base raise for most teachers and award stipends for many leadership areas. Dr. Studebaker-Bolinger said we are appreciative of our teachers and the work they do every day to make our students and schools successful.

Mrs. J. Imel said she was appreciative of the team.

DISCUSSION INFORMATION

BUILDINGS AND GROUNDS UPDATE – MR. FRAZIER

Mr. Frazier congratulated Miss Eisenhardt.

Mr. Frazier gave the following buildings and grounds update:

Current Update

The Junior High locker room is on target and there were no change orders. The expected completion date is August 21 except for the HVAC unit and it will be set by the end of August.

The air-conditioning units at the high school will be set by crane on Monday, August 17.

Today, two more HVAC units failed. One at Anderson Elementary School and the other at the high school (counseling area). These units are 30 years old and need to be replaced.

There has been an issue with transporting transfer students to needed spots.

The high school Media Center area is not acceptable for student use at this time. The water damage was severe and the smell and mold is difficult to mitigate. We are looking for temporary solutions. We also have a HVAC unit over the library that has failed but we are not recommending a replacement at this time. This library area would be relocated upon approval of the Bond.

Dr. Studebaker-Bolinger said these are difficult decisions to make when given the information three weeks before the start of school.

Dr. Studebaker-Bolinger said teachers voiced concerns with Acuity when she met with them last December. She said in two previous districts she had worked with NWEA. She said it is a very expensive assessment but is much more helpful. Dr. Studebaker-Bolinger thanked the staff at Deputy Elementary for piloting NWEA. She thanked Dr. Jenner and Mrs. Vaughn for their work on this issue.
