Mr. Strassell said "Five years ago I read an article in the Times about a cutting edge high school in the suburbs of Chicago. This school was keeping a group of students for five years and graduating them with an associate's degree. I remember thinking how awesome that was. At the same I remember thinking how close MCHS was in accomplishing that same goal. My life has been all about Advanced Placement classes from the beginning of my teaching career. AP philosophy is now and always has been giving high school students the opportunity to earn college credit in high school. The availability of dual credit has taken that philosophy one step further. Our partnership with Ivy Tech has taken this whole idea of high school students earning college credit to the cutting edge. For the last several years I have had the opportunity to teach Saturday school for the National Math and Science initiative. I have been in over 25-30 high schools in the State of Indiana. When I tell my colleagues throughout the state what we are doing with our Ivy Tech Partnership they simply cannot believe it. We definitely are at the cutting edge of something that is absolutely amazing for high school students. We have well over 50 students this year who will graduate with at least 30 college credits which is half way to an associate's degree many who will have over 40 close to 50 credits. Credits guaranteed by the TGEC. You will see in a moment what this means financially but I feel it is even more advantages to the students in the amount of different opportunities having those credits will give those students. Many of these students will be able to finish a traditional four year degree in three years or less, many will be able to finish graduate degrees within four years. We actually have several students who have taken a few extra classes during the summer who are going to earn that associates degree during their four years at MCHS. An associate's degree that they will have for the rest of their life. That dream is being fulfilled! We are that cutting edge high school!! Thank you Board on behalf of our students!!"

# Lydia Middleton Update on School Improvement and School-wide Title I Plan

The 2015-2016 Lydia Middleton School Improvement Plan set out some goals in the areas of literacy, mathematics, and attendance to move staff and students in a forward direction. Since developing that initial plan, we have worked hard to identify student needs and move all students toward growth and proficiency. This presentation will provide an update on our progress. It will address the following:

- Global Preparedness and Career Readiness

### Goals: Lydia Middleton School Improvement Plan/Title I Plan

**Mathematics**: By the end of the 2015-2016 school year, all students in grades kindergarten through grade two will show growth in mathematics as measured by math facts assessments given at each grade level, while all students in

grades three through five will demonstrate proficiency on ISTEP+ or meet their projected growth targets as measured by the NWEA Assessment.

**Literacy K-2**: Eighty-five percent of students in grades 1-2 will meet projected growth in reading foundations, comprehension of fiction and nonfiction, writing, and vocabulary as measured by the NWEA Assessment. Students in kindergarten will demonstrate growth in reading foundations, and writing as measured by NWEA and personal writing portfolios.

**Literacy 3-5**: By the end of the 2015-2016 school year, 85% of Lydia Middleton students will meet or exceed the ISTEP+ cut score in English/language arts, or meet their projected growth target in reading as measured by the NWEA Assessment.

**Attendance**: By the end of the 2015-2016 school year, the attendance rate at Lydia Middleton will be 97% or higher.

### Action Plan for the Mathematics Goal

Mathematics: The action plan developed for Lydia's School Improvement Plan outlines numerous strategies for achieving the goals set forth in the plan.
